Host Bar: The beverage service is paid entirely by the Host. Taxable Service charge, State and Local taxes will be added to the final bill.

Cash Bar: All beverages are paid at time of purchase at cash bar prices. Bartenders are not allowed to run tabs.

Bartenders: The Interstate Center will provide Bartenders for both Cash and Host bars. If your bar does not reach \$125.00 per hour, per bartender, we will assess a \$50.00 per hour additional charge for each bartender. Any portion of an hour will be charged as a full hour.

Pricing: Pricing is established by the facility in accordance with local liquor ordinances and taxation rates, and may change without notice due to market conditions. Firm prices will be quoted 30 days prior to your function.

Beverage Rules: The Interstate Center reserves the right to refuse service to any person(s) deemed unsafe. The Interstate Center reserves the right to refuse service to any person under age.

- All closing times must meet local ordinances.
- No alcoholic beverages may be brought onto the Interstate Center Property.
- The location of all host or cash bars will be at the discretion of the Interstate Center.
- Limited Bar Service of 6 hours MAXIMUM, or 11:00PM.
